


Fund Performance

In August, the Fund decreased by c.1.8% MoM, since Inception (31st of October 2012), the Fund is up by c.33.3% and Year-to-Date the fund is up by c.1.4% while focusing primarily on capital preservation. Assets under management stood at QAR12m of end of August 2019.

We advocate the quality style comprising high growth, defensive earnings, high dividend yield and low debt / equity in the mid-large cap part of the market while actively managing beta. We believe, macro policy changes, liquidity, commodity prices and growth expectations will remain key drivers of risky asset prices.
