


Fund Performance

In March, the Fund decreased by c.0.27% MoM; since Inception the Fund is up by c.0.29% and Year-to-Date the fund is up by c.0.14% while focusing primarily on capital preservation as well as robust yield generation.

The Fund will achieve diversification by investing in a basket of quality sukuk with various maturities, various risk/returns, yield and rating profiles, from a variety of issuers globally.
