


FUND PERFORMANCE

In January, the Fund increased in value by c.1.2% MoM; the fund was up c.9.5% in 2019 and c.13.9% since inception. The fund focuses primarily on capital preservation and robust yield generation. The Fund distributed USD28 per unit on the 3rd of February 2020, present AuM is c.USD162m.
