

FUND PERFORMANCE


In January, the Fund decreased c.0.1% MoM and up c.21.2% since inception. The fund focuses primarily on capital preservation and robust yield generation. The Fund dividend yield equated to c.5.0% for 2019, c.5.2% for 2020 and c.4.5% for 2021. The Fund directors agreed to distribute USD 22 per unit in February 2022.
