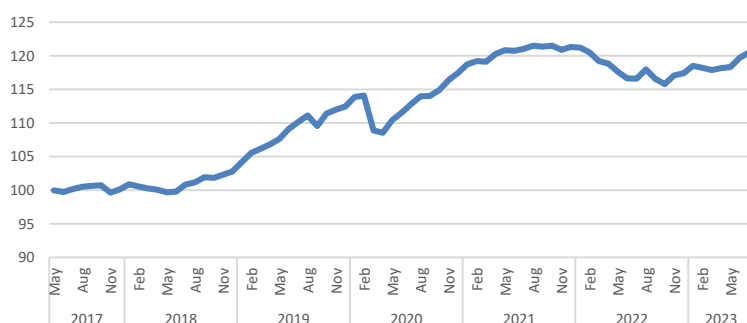

FUND PERFORMANCE

In July, the Fund increased c1.5 % MoM, the fund is up c 3.2% Year-to-Date and up c.20.49% since inception. The fund focuses primarily on capital preservation and robust yield generation. The Fund dividend yield for the past three years equated to c.5.2% for 2020, c 4.5% for 2021 and c 4.4% for 2022. The Fund directors distributed USD 23 per unit in February 2023 and have declared a dividend of USD 24 for August 2023.

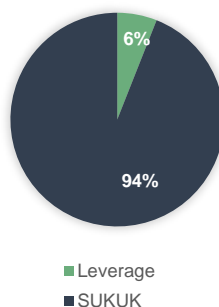

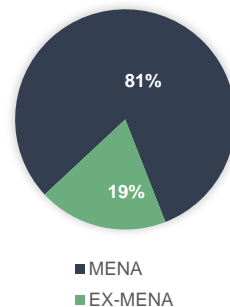

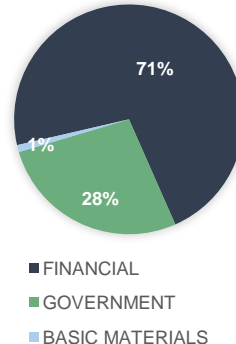
LEVERAGE CONTRIBUTION
